DESCRIPTION

Furnish all necessary machinery, tools, apparatus, and other means of construction, and for the bid price listed, install the items herein described in strict accordance with the requirement of the current Michigan Department of Transportation specifications and/or the Standard Specifications for Road and Bridge Construction of the Michigan Department of State Highways and in accordance with Standard Plan Series and special detail.

REQUIREMENT

Proof of current M.D.O.T. prequalification's rating for the type of work proposed included with bid application. Your rating will not be disclosed to other bidders and will be returned. Failure to make submittal will result in rejection of bid.

PAYMENT

Payment by the Road Commission will be available within thirty days of approved bills and receipt of township moneys, if applicable.

CONTRACT PERIOD

Bids must apply and be held for a period of (12) months from the bid date. This agreement may be extended for a longer time with mutual agreement by both parties.

FAIR EMPLOYMENT PRACTICES

The contractor agrees that they will not discriminate against any employee or applicant for employment, to be employed in the performance of this contract with respect to their hire, tenure, terms, conditions or privileges of employment or any matter directly or indirectly related to employment because of their age, (except when based on a bona fide occupation qualification), or because of their race, color religion, national origin, ancestry, sex height, weight, marital status, veteran status or handicap unrelated to the ability to perform the duties of a particular job. (Act No. 251 P.A. 1955, as amended)

INSURANCE REQUIREMENTS

Workers Compensation (Must comply with one of the following):

- 1) Workers' Compensation coverage. The contractor shall, provide with their bid, a certificate that he carries Worker's Compensation Insurance, with a 10-day notice of cancellation clause included. The Employers Liability amounts shall be \$500,000/\$500,000/\$500,000.
- 2) Excluded under the Workers' Disability Compensation Act. The contractor shall, provide with their bid, Exclusion Form MDL 337, provided by the Bureau of Workers' Disability Compensation.
- 3) Sole Proprietor with no employees, casual labor and or contractors. The contractor shall, provide with their bid, a Sole Proprietor Statement.

General Liability

The contractor shall save harmless and indemnify the Board of County Road Commissioners of the County of Lapeer against all claims for damage to the public or private property and for injuries to the persons arising out of and during the progress and to the completion of the work.

The contractor shall, provide with their bid, a certificate that he carries General Liability coverage with the Lapeer County Road Commission added as additionally insured, with a 10 day notice of cancellation clause. General Liability amounts shall be \$1,000,000 each occurrence/\$2,000,000 aggregate including products/completed operations.

Automobile Liability (If applicable)

The contractor shall, provide with their bid, a certificate that he carries Automobile Liability coverage with a 10 day notice of cancellation clause. Automobile Liability amounts shall be \$1,000,000 for owned, non-owned and hired vehicles.

Operations shall not commence until insurance is in force and will cease if it is canceled.

MAINTAINING TRAFFIC

This work will be open to traffic during the life of the project. Two flag persons and a three sign series will be required to maintain traffic, if applicable. Maintaining traffic will be paid for under the bid item of mobilization.

STATE HIGHWAYS

The bids may be extended to State Highway work. If State Highway work is added, the Lapeer County Road Commission and the contractor will determine who will handle additional signing and flagging, if needed.
