**CORRUGATED METAL PIPE, PIPE ARCHES, SECTIONAL PLATE
OTHER CULVERT AND BRIDGE MATERIAL**

1. All material quoted shall meet the current standard specifications of the Michigan Department of Transportation for Class "A", riveted and spiral corrugated metal pipe and corrugated metal pipe arches. Specific reference is made to Section 909.05 of the 2003 Standard Specifications for Construction of the Michigan Department of Transportation.
2. Basis of Quotation: Per Lineal Foot, F.O.B. any location in Lapeer County.
3. The Commission reserves the right to reject any or all bids, to waive irregularities in the bidding and to award the bid in any manner deemed to be in the best interest of the Road Commission.
4. Purchase Orders are required for all purchases. This number must be given to vendor at the time of order placement and referenced on all packing lists, invoices and other correspondence. Failure to follow these requirements may result in delay or non-payment of invoices.
5. A letter of MDOT certification to be included with bid.
6. Any minimum load size or additional drop charges must be clearly noted on bid.
7. Delivery time in excess of five working days may be cause to utilize alternate vendors.

SPECIFICATIONS

ITEM #1 - Annual supply of spiral corrugated steel pipe sizes 12" thru 96", 2 2/3" X 1/2" corrugation and 3" X 1" corrugation. Prices for corresponding bands and end sections are to be included. Pipe ends are to be recorrugated. Pipe gauges are to be as specified by MDOT. Prices to be firm for one (1) year from date of bid and F.O.B. Lapeer, Michigan.

ITEM #2 - Bidders are requested to submit prices on sizes from 12" to 72" or equivalent pipe arches and connection bands. All prices to be firm for one (1) year from date of bid and F.O.B. Lapeer, Michigan.

ITEM #3 - Annual supply of plastic culvert pipe sizes 4" through 24". Prices on connecting bands and other fittings to be included also. Prices to be firm for one (1) year from date of bid and F.O.B. Lapeer, Michigan.

ITEM #4 - Bidder may attach other sheets showing prices for other products. This will include sufficient information to define type of product, material specifications and all other related information to allow the Road Commission to evaluate the product. All prices to be firm for one (1) year from date of bid and F.O.B. Lapeer, Michigan.
