Committee Reports

Finance Committee Report:

Mr. Hodge reported that the Finance Committee met at 8:00 a.m. and approved the payment of bills in the amount of \$240,673.93.

Other Meetings Attended:

Mr. Suma stated that he had attended the County Commission meeting.

Manager's Report:

Mr. Pearson explained that the Snow Removal Bids were opened on December 1, 2008, and although the Road Commission will attempt to plow the subdivisions themselves, there are times when the accumulation is more than we can handle.

Motion by Mr. Suma, seconded by Mr. Hodge to approve the 2008-09 Bid Tabulations for Snow Removal as presented and award in the best interest of the County.

Mr. Pearson stated that the bids had been received for the upfitting with hydraulics for truck #1256. Mr. Pearson explained that the upfitter will also install the blade onto the truck.

Mr. Pearson informed the Board that the wing plow was in service and being used.

Mr. Pearson explained to the Board that the new water well was now complete and going through its required testing for a period of time, and the electrical transfer switch had also been installed at the Lapeer location.

Mr. Pearson explained to the Board that winter had arrived and the crews were working more hours. Mr. Pearson stated that with the State's change in winter maintenance, there is a longer delay in getting to the primary roads, local roads and sub-divisions. Mr. Pearson stated that all roads will be cleared, but he was sticking to the priority list. The salting process will switch to salt/sand when appropriate. Mr. Pearson stated that he was fearful that there will not be any salt available for purchase after the 7,000 ton of contracted reserve material is received.

Mr. Orrie Smith, Weighmaster

Mr. Smith stated that he is still busy with the over-size escorts. Mr. Smith explained that the government is providing temporary housing to insurance companies using the double wide trailers from the south. These houses are them moved in for families that have been burnt out. Mr. Smith estimated that there are close to twenty of these houses in the County at this time. Deputy Smith stated that he has also given out a lot of the snow removal warning tags for improper plowing of snow on or near the roadway.

Engineer's Report:

Mr. Meinz stated that the traffic signal maintenance bids are due December 16, 2008. Mr. Meinz then asked that the Board approve the TCO for a yield sign on East Court.

Ms. Younger asked for consideration when plowing near her drive as the driver makes the turn at her driveway.
