Committee Reports:

Finance Committee Report:

Mr. Hodge reported that the Finance Committee met at 5:00 p.m. and approved the payment of bills in the amount of \$468,970.67.

Directing Manager Report:

Mr. Pearson explained to the Board that he met with a representative from the Wing Nuts Radio Controlled Airplane Club. Mr. Pearson went on to state that the Road Commission has received a complaint from a neighboring resident regarding the noise from the planes. The Club has tried to accommodate the resident and is now using a decibel meter to monitor the sound emitted from the planes. Mr. Pearson explained that the Club would like to continue using the site adjacent to the Road Commission garage. Mr. Pearson stated that he would like to refer the complaints regarding the noise to the Township of Mayfield, the governing body. Mr. Pearson explained that he will create a resolution for the next Regular Meeting, allowing for the continuance of the use of the property.

Mr. Pearson then went on to speak about the GASB45 requirement regarding retiree health insurance costs and estimated future costs. Ms. Erickson explained that an actuarial is required to calculate the liability for the futuristic costs, but that the proposed company will create the document for no cost if the Road Commission begins an investment account with them.

Mr. Meinz asked the Board to approve the agreement with MDOT.

Mr. Dahn was present to speak about the flooding problem his road. Mr. Dahn stated that his driveway is in a low spot. Mr. Dahn explained that a foreman has been out to look at the drainage problem and determined that changing the size of the culvert will affect the flow to the homeowners downstream. Mr. Meinz and Mr. Doyle stated that the land is very flat with the road being level with the adjoining land.

Brief discussion ensued regarding the reoccurring flooding issue. Mr. Dahn was instructed to present the issue to the Township. Attica Township will then contact the Road Commission to prepare an estimate for the cost to improve the flow of water.
