Meetings Attended:

Mr. Suma stated that he had attended the Lapeer County MTA Chapter Meeting in Burlington Township and explained that he had asked to have the Road Commission put on the agenda for the February meeting to present the 2013 prices for services. This meeting will be held on February 19, 2013 at the Burnside Township Hall.

Manager's Report:

Mr. Pearson explained that he had received the letter from Fahrner Asphalt regarding the request to extend the 2012 chip seal and fog seal prices into the 2013 road construction season. Mr. Pearson stated that with the fuel and oil market as it is, he believes this offer is a good deal. Mr. Pearson explained that this agreement will allow him to give prices to the Townships as early as the Township Meeting so they can begin to plan summer projects.

Mr. Pearson briefly spoke about the extra projects that were completed which caused the Road Commission to be over budget. These projects included the Imlay City Road improvement, the overlay for Peck Road and some chip seal.

Mr. Doyle stated that the low bid for the 2013/14 proposals came in three times higher than last year. Mr. Doyle stated that he was very happy with the work BMJ did for us last year and will continue to use them on time sensitive issues.

Mr. Doyle stated that he received a call for Congestion Mitigation and Air Quality projects for 2014-2017, which are due by January 11, 2013. Mr. Doyle explained that he is applying for a roundabout at the Davison/Lake Nepessing/Genesee Road intersection for 2015 and an eastbound passing flare on Bowers at Roads Lake for 2014.

Mr. Suma suggested a passing flare on M-53 at Armstrong Road. Mr. Doyle stated that M-53 is a state road and those types of improvements are done by the Michigan Department of Transportation. Mr. Doyle explained that we have mentioned this to MDOT in the past.

Public Comment:

Mr. Buckel wished Mr. Suma and Mr. Hodge "Good Luck".

Board Discussion:

Mr. Duckert asked if there was sand being added to the salt, as he could not see it on the roadway. Mr. Duckert stated that this is the perfect time of year to be using the salt sand mixture. Mr. Pearson explained that the crews have been instructed to use the sand, and he would speak with them about it.
